Applications in prescribed format along with details of qualification, experience are invited from Indian Nationals for recruitment to the post of **Deputy Director Examination (MBA/MCA/Other)**. The appointment will be tenure based for a period of 05 years. The application format and other details can be downloaded from the BPUT website (www.bput.ac.in).

Pay Scale:

- i) If a Teacher in permanent position of Govt. / Semi Govt. Institution of Odisha enjoying the scale of Rs.15600-39100 + AGP Rs.6600 or above (Pre-revised) is deployed with the AICTE requisite qualification, then he/she shall be eligible to draw pay at Level-12 of the Odisha Revised Scale of Pay (for Teachers of Engineering College/ Degree level Technical Institutions / Universities) Rules, 2019 as applicable to BPUT Asst. Professors. His / Her pay may be protected as per BPUT rules.
- ii) If an outsider (fresh candidate) with the essential qualifications & eligibility criteria is selected, then he/she shall draw entry pay of Rs.67700 + DA at Level-13 of the Odisha Technical Universities (non-teaching employees) Revised Scale of Pay Rules, 2018 (i.e. scale of pay relevant to the Grade of pay of Rs.6,600).

Essential Qualification and Eligibility criteria requirements (within last date of Application):

a) MCA with Ph.D degree with good knowledge in computer application.

OR

MBA with Ph.D degree in Management with good knowledge in computer application.

OR

PG with PhD degree in Sciences / Architecture / Pharmacy.

and

b) Must have First Class or equivalent either at Bachelors or Masters level and 60% marks or 6.75 CGPA in aggregate shall be considered equivalent to first class if first class or division is not awarded by the concerned institution or the equivalence CGPA as notified by the concerned institution. A copy of the notification must be attached for proof.

and

c) Must have published at least 03 numbers of research papers in SCI / UGC / AICTE listed journals.

and

 d) 05 years of experience at the level of Assistant Professor in Teaching or Research in AICTE recognized institutions.

OR

05 years of experience in the post of Assistant Controller / Assistant Director of Examinations or above post in any Affiliating University with Good Knowledge of Computer Applications in handling E-Examinations.

a) Should be within 55 years of age on the last date of application i.e. 03/03/2023.

Step 4- From "Educational Institutions Name", Select-> "Biju Patnaik University of Technology, Rourkela"

Step 5- From "Select Payment Category", select-> "Recruitment"

After transaction / payment, the payment slip needs to be attached with the application.

Last date for Receipt of Application:

The applications will be accepted only by Speed Post; No Hand Delivery is acceptable. In-service candidate(s) need to forward his/ her application through the employer or need to submit a 'No Objection Certificate' from the employer at the time of interview. The sealed envelope containing the application form and other documents should be super-scribed as "Application for the post of Deputy Director Examination (MBA/MCA/ Other),BPUT, Rourkela" and reach the Registrar, BPUT, Chhend, Rourkela -769015 on or before 03/03/2023. Minimum eligibility does not ensure that a candidate will be called for interview and/or selected; the decision of the authorities is final. No correspondence in this regard shall be entertained.

General Information:

- Mere fulfillment of qualifications, eligibility and experience requirements etc. does not entitle a candidate to be called for an interview.
- 2. The University reserves the right to fill-up or not to fill-up the post advertised or even to cancel the entire advertisement / selection process without assigning any reason thereof.
- 3. No correspondence whatsoever will be entertained from the candidates regarding postal delays, conduct and result of interview and reasons for not being called for interview or selection.
