Age Limit:- The upper age limit shall be 35 years.

The upper age limit is relaxable upto 5 years in the case of applicants belonging to schedule caste/scheduled tribes, physically handicapped and women applicants whereas 3 years in case of OBC (Non-Creamy layer candidates)

- There will be no age relaxation for SC/ST/OBC candidates applying for unreserved seat.
- horizontal reservation applicable as per UP Government rules.

Duration:- RA will be tenable initially for a period of one year, which may be extendable upto two more years based on his/her performance.

Stipend:- The fixed consolidated stipend of RA will be as follows:-

1	1st Year: 36,000/- per month
2	2nd Year: 38,000/- per month
3	3rd Year: 40,000/- per month

Selection Procedure:-

- (a) Selection will be made through interview whereby the assessment of academic record and published/project work is tested by discipline-wise high-level expert committee.
- (b) Merely fulfilling of eligibility criteria may not entitle a candidate for being called for interview. Candidates will be called for interview after screening on the basis of criteria adopted by CBMR depending on the number of RAs available. CBMR reserves the right to call or not to call a candidate for interview.

- Application format is available at Centre's website <u>(https://cbmr.res.in/)</u>. Application duly completed on prescribed form should be sent, with copies of proofs of educational/academic qualifications, experience, testimonials, research publications etc, as indicated there in.
- Reservation: Reservation rules will be applicable as per 'The Public Services (Reservation for Scheduled Castes, Scheduled Tribes and Other Backward Classes) Act, 1994' and Government orders issued from time to time for the domicile of Uttar Pradesh. Certificate issued by competent authority on prescribed format of Government of Uttar Pradesh is required for the claim of any reservation i.e. SC/ST/OBC/EWS/PWD.
- Scheduled Caste, Scheduled Tribes, Other Backward Class, Dependents of Freedom Fighter, Persons with Disability, Ex-Serviceman and women candidates who are not the permanent residents of Uttar Pradesh shall not be given the benefit of reservation/age relaxation.
