Sub: Filling up of the posts of Superintendent on Deputation basis at Central Water and Power Research Station, Khadakwasla, Pune.

It is proposed to fill up **Fourteen (14)** posts of Superintendent (Group 'B', Non-Gazetted, Ministerial) at CWPRS, Khadakwasla, Pune-24 (Government Organization under Ministry of Jal Shakti, Department of Water Resources, River Development and Ganga Rejuvenation), **on deputation** basis in Level 6 in Pay Matrix (Pre-revised PB-2 Rs.9300-34800 + Grade Pay Rs. 4200/-) from **Officials of the Central Government**:

- (a) (i) holding analogous posts on regular basis in the parent cadre or department; \mathbf{OR}
 - (ii) with six year's regular service rendered after appointment to the post on regular basis in the level -5 in the pay matrix (Rs.29200-92300) or equivalent in the parent cadre or department and
- (b) Possessing the following educational qualification and experience:.
 - (i) Bachelor's Degree from a recognized University or Institute; and
 - (ii) Two years experience in Administration or Establishment work in Central Government Office.
- **Note 1:** The period of deputation including the period of deputation spent in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed three years.
- **Note 2:** The maximum age limit for Appointment by Deputation shall not be exceeding 56 years as on the closing date of receipt of Applications.
- **Note 3:** The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly the deputationist shall not be consideration for promotion.
