3. Private practices of any kind will not be allowed for full time contractual engagements.
4. ESIC may increase or decrease or cancel filling up of any or all the post without assigning any reasons at the discretion of the Appointing Authority.
5. No TA/DA will be paid to the candidates for appearing in the interview.
6. Application should be submitted in the prescribed form appended below. It should be filled up in block/capital letters by the candidate in his/her own handwriting.
7.
