### NOTIFICATION

Applications are invited from qualified Indian citizens for appointment to the post of Senior Computer Programmers on contract basis to provide technical support for the existing systems and services in the High Court and the Subordinate Courts. Candidates shall apply offline. The application shall be in the format attached herewith appending all the necessary documents, as mentioned in this notification. No other means/modes of application will be accepted.

**1. Recruitment No : IT-1 / 2023**

**2. Details regarding the name of the post, number of vacancies, Educational qualification, experience and salary :**

<b>Experience</b>	Must have 3+ years experience in the field of programming/development/testing in Government or reputed National/International firms.

**3. Nature of appointment :** The appointment will be on contract basis. The contract will be till the expiry of the Financial Year in which the appointment is made. The contract may be extended further based on the performance of the candidates & requirement of the High Court, subject to sanction by the High Court and /or the Govt of Kerala.

**4. Validity of Rank list :** The rank list prepared pursuant to this notification shall remain in force for a minimum period of one year from the date of publication and shall continue to remain in force until the publication of a fresh list or till the expiry of three years, whichever is earlier.

Vacancies that may arise during the period of validity of the rank list shall also be filled up from the list.

**5. Age limit :** Candidates should be born on or after 02/01/1982.

**6. Mode of Selection :**

1. A written/ objective test may be conducted to shortlist the candidates, based on the number of applicants.

2. The shortlisted candidates have to undergo a practical/skill test to assess the technical skill set mentioned in the notification.

3. Those candidates clearing the practical/skill test will be called for an interview.

The final list of selected candidates will be prepared on the basis of the performance of the candidates in the practical/skill test and interview.

Note :- Merely satisfying the eligibility criteria does not entitle a candidate to be called for the practical test/interview. The cut-off mark for the above tests will be as decided by the High Court. The High Court reserves the right to alter the mode of selection mentioned above at any stage.

**7. Fees :** There shall be no application fees.

**8.** The candidates satisfying the eligibility criteria mentioned in the Notification may send the duly filled in application form in the prescribed format(appendix), along with copies of the documents as detailed below in an envelope superscribed with 'Application for the post of Senior Computer Programmer, Recruitment No. IT 1/2023' through registered post / speed post, to **the Registrar (Computerisation) -cum- Director (IT), High Court of Kerala, Ernakulam-682 031 or may drop the same in the box placed in the IT section, 5th Floor, High Court, for the purpose.**

**9. Documents to be attached along with application form:**

1. Detailed Resume.
2. Self Attested Copy of Matriculation/equivalent Certificate to prove age.
3. Self Attested Copies of Educational Qualifications.
4. Self Attested Copies of Experience Certificate/s proving 3+ years experience in the field of programming/development/testing.

Note : Experience certificate/s in this regard shall be issued by the competent authority of the office/company wherein the applicant had worked and acquired the experience for the post.

**10.** The originals of all the documents mentioned in Point No. 9 shall be produced for verification as and when called for by the High Court. Failure on production of the documents will entail cancellation of the candidature.

**11. Intimation for Test/Interview:** All intimations with regard to the recruitment will be sent through the e-mail ID/mobile number provided by the candidate in the Application form. For this, the candidates are advised to keep the e-mail ID/mobile number active during the period of recruitment process. No request for change of e-mail ID/Mobile Number provided will be entertained. No intimation will be sent through any other mode.

**12.** Candidates should ensure that the particulars furnished by him/her are correct in all respects. Anything not specifically claimed in the application against the appropriate field will not be considered at a later stage. In case it is detected at any stage of the recruitment that a candidate does not fulfill the eligibility norms and/or that he/she furnished any incorrect/false information or has suppressed any material facts, his/her candidature will stand cancelled. If any of these shortcomings are detected even after appointment, his/her service is liable to be terminated.

**13.** The person appointed on contract basis will have no claim for regularization under any circumstances. Further, the selected candidates will have to execute an agreement with the High Court fixing and regulating conditions of service.

**14.** Candidates possessing degrees which are not awarded by the Universities in Kerala should obtain certificate of recognition of their degrees from any of the Universities in Kerala and produce the same as and when called for.

**15.** While applying for the post, the candidates should ensure that he/she fulfills the eligibility and other norms mentioned above. The candidate should have acquired the prescribed qualification/experience as on the date of notification.
